CERTIFICATE OF PROFESSIONAL COMPETENCE FOR VEHICLE OPERATORS

Freight - Passenger Transport



Transportation of Road Freight and Passengers in the United Kingdom and abroad is a critical function that needs expert control in the operation and administration of vehicle movement.

Legislation is laid down for Companies operating vehicles over 3.5 tonnes gvw, for hire or reward to prove Professional Competence, and the Operator or Transport Manager **must** hold a Certificate of Professional Competence (CPC).

A CPC National Certificate is required for operating in this country and an additional CPC International Certificate for operating Vehicles overseas.

The CPC National Examinations for Freight operations consists of three examination.

Unit 1 – a multi-choice question paper - 30 questions

Unit 2 – a multi-choice question paper - 40 questions

Unit 4 – a case study - 8 questions requiring extended response answers based on a pre-released scenario about a fictitious freight transport company.

If you then wish to get the CPC International Certificate for Freight you need to take.

Unit 6 - Freight International. 10 - 12 direct questions requiring short answers.

The CPC National examination for Passenger Transport Operations consist of three examinations.

Unit 1 – a multi-choice question paper - 30 questions

Unit 3 – a multi-choice question paper - 40 questions

Unit 5 – a case study - 8 questions requiring extended response answers based on a pre-released scenario about a fictitious passenger transport company.

If you then wish to take the CPC International Certificate for passenger transport you need to take.

Unit 7 - International Passenger Transport Operations, 12 - 14 direct questions requiring short answers.

We run four CPC courses per year to coincide with the four examination dates fixed by the OCR Examination Board.

Our Freight National courses consist of ten consecutive days prior to the examinations.

Passenger Transport National courses consists of three days of training together with home study.

Freight International course consists of four days training.

Passenger Transport International courses is home study only.
