### What is the length of time my data is retained by the GTA?

The period of time that data is retained starts from the successful completion and close down of the course. We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information, for example data about your training records and invoices for 7 years.

#### Who has access to your information?

IMI:

Your information will be shared with the GTA administration, course delivery staff (trainers) and awarding bodies, as identified in the table on page 2 (Table 1). This enables the awarding bodies to be able to manage approved centres. The transfer and disclosure of personal data between our organisations is undertaken on a data controller to data controller basis. Both are separately responsible for complying with the obligations of the General Data Protection Regulation.
